- Copy of the **last three wage slips** (where you have assigned yourself a salary).
- Copy of a **letter from a chartered accountant** stating your current gross and net income, and if possible, a statement of the projected income for next tax year.

4. If you have not made a choice of property or you do not know the details of the property you wish to purchase, leave box number 4 blank (property details box).
